Targeted Action Research Projects (TARP) will be made available to all staff who seek CTLE and/or in-service credit. TARP projects have been designed to provide independent learning opportunities to William Floyd School District members. To ensure safety and sustainability of TARP, the following procedures will be implemented:

- Members can obtain a TARP kit from their building representative during a specific sign out period. The Fall 2021 window is 10/18/21~10/25/21. Kits may not be signed out after this time.
- Teachers will be charged a \$30 registration fee (Teaching Assistants will be charged \$10). Payment in the form of a check/money order made out to **William Floyd Teacher Center** will be collected upon the receipt of a TARP kit. This fee is nonrefundable if the project is not completed within the allocated time frame.
- Members will be limited to enrolling in one TARP during the enrollment period.
- Once a TARP kit has been secured, enrollees will be given access to assignments in CANVAS.
- All Fall semester work must be completed by 12/13/21. Kits must be returned by 12/20/21
